ENTRY FEES: \$27.00 for the first entry per dog per day; \$20.00 for the second entry of the same dog each day; \$18.00 for the third entry; \$17.00 for the fourth and fifth entries. Fees include AKC recording fee of \$3.50 per dog per day for the first entry and \$3.00 for each additional entry of the same dog.
